Dear Director:

The National Association of County Human Services Administrators (NACHSA) has appreciated your past support and asks you to please renew your dues for 2012 today.

We all continue to experience historic budget stresses and huge caseloads. Given reduced support at the state and federal level, many of you have curtailed travel and reduced the number of organizational memberships.

Given the tough choices you face, I truly believe that renewing your NACHSA membership continues to be a great investment. NACHSA has frozen dues for eight years but has increased its services to county administrators over that time. In 2011, NACHSA sent 20 timely *e-Alerts* on federal legislative and regulatory developments, grant opportunities, human services resources and best practice information. The NACHSA *Networker* published stories on county innovative programs and news of NACHSA meetings conducted at National Association of Counties' (NACo) conferences. And, NACHSA provided scholarships to travel to California to participate in a two-day poverty symposium.

NACHSA is also engaged in the federal policy process. For example, NACHSA members responded to a request by the Obama Administration to craft recommendations to HHS on policy and regulatory changes that would remove service delivery barriers. NACHSA also prepared and submitted testimony for the Congressional hearing record on reauthorizing TANF. NACHSA also represents counties in coalitions, including one to protect the Social Services Block Grant. With your help and involvement, these efforts will continue.

NACHSA also provides networking opportunities for county directors. NACHSA members convene at NACo's legislative and annual conferences and participate alongside county elected officials as NACo crafts national health and human services policy. Through our broad array of contacts, NACHSA also assists individual members in identifying and contacting colleagues to help you tackle your agency's specific issue that you may be addressing. Via monthly conference calls, the Board keeps their colleagues up to date on local trends, and they help us in informing county colleagues in their state of federal developments.

During 2012, NACHSA will continue to serve you in these ways. Tom Joseph, NACHSA's Washington Representative with over 30 years of county-based experience and Marilina Sanz, a veteran NACo human services lobbyist will continue to advocate and guide us in Washington, DC.

Thank you in advance for your support and participation.
